



Executive Summary

The number of confirmed COVID-19 cases globally is approaching 2.1 million, with approximately 135,000 deaths and around 515,000 recoveries. Nearly all countries globally have reported at least one case and/or have implemented some form of travel restriction. The situation continues to evolve rapidly, with new travel restrictions, both internationally and domestically, being implemented with little or no notice.

Solace Global advises against all non-essential travel at this time due to the already widespread in-place travel restrictions and the risk of new ones being implemented without notice. Additionally, prior to any and all essential travel, it is advised that you check your relevant government's travel advice and contact your airline or travel provider for more details. People aged 70 and over, or those with underlying health issues, should also reconsider their need to travel, even domestically, as to limit their chances of exposure.



Latest Updates

The head of the World Health Organisation (WHO) has expressed dismay over the loss of over \$400 million from the organisation's budget following the United States' decision to halt its contributions. Media reporting indicates that there was a near-unanimous agreement amongst White House officials that the WHO is too heavily influenced by the Chinese Government. WHO officials have pushed back strongly against accusations of political bias and have indicated that they will explore other options to fill any financial gaps that they may face in the near future.

In the United Kingdom, the National Police Chiefs Council (NPCC) has announced that thousands of fines have been issued in recent weeks to individuals and groups who breached social distancing measures aimed at slowing the spread of COVID-19. Despite these numbers, data suggests that the vast majority of the British public are adhering to current guidelines. Pressure is building on the government over persistent shortages of personal protective equipment (PPE) and the scale of the outbreak in care homes. Despite outbreaks of COVID-19 being reported in over 2,000 care homes, official government figures currently only account for confirmed cases of the virus and related deaths in hospitals. Questions on the issue are likely to continue until the government changes its stance and includes social care statistics in its official figures.

German Chancellor Angel Merkel has announced plans to ease restrictions in place to fight COVID-19. As per her statement, a limited number of non-essential businesses will be allowed to reopen from 20 April, with schools scheduled to reconvene on 4 May. The majority of social distancing measures, however, will remain in place, with bars and restaurants to remain closed and large gatherings outlawed. Further announcements regarding lockdown measures are expected on or shortly after 30 April. Meanwhile, a ban on large public events will be upheld until August 31 to prevent possible mass transmission of the virus.

In similar news, during a press conference, Australian Prime Minister Scott Morrison announced that current restrictions are to remain in place for an additional four weeks, although the relaxing of measures is on the agenda. Australian authorities claim to have one of the highest reported detection rates anywhere in the world and estimate that roughly 92 per cent of all symptomatic cases are being detected nationwide. The country currently has 6457 confirmed cases with only 63 deaths.

Over a third of the sailors on board the French aircraft carrier, Charles de Gaulle, have been tested positive for COVID-19. Approximately 670 of the crew of 2,000 have been found to have the virus, with several dozen crew members receiving treatment in hospital and at least one in intensive care. The battle group which the carrier was leading has been forced to return to port from the Atlantic Ocean. There are also cases of the virus onboard one of the carrier's escort vessels. The case of the Charles de Gaulle is reminiscent of a similar outbreak on board the American aircraft carrier USS Theodore Roosevelt and underlines the ongoing threat that COVID-19 poses to military, particularly naval, capabilities.

Singapore has recorded its largest daily jump in cases of COVID-19, with 447 cases confirmed on 16 April. The country had garnered international praise for its swift action to tackle its initial outbreak but now appears to be suffering a second wave of the virus. Evidence suggests that COVID-19 has spread rapidly in Singapore's large migrant worker community. There are indications that roughly half of the new cases in Singapore are linked to large dormitories that house

migrant workers. Rights groups, charities and medical experts have flagged the potential for mass infection among the more than 300,000 migrant workers living in often cramped and unsanitary conditions.

Previously dismissed as a conspiracy theory, reports have emerged that COVID-19 may have emerged as a result of poor biosecurity measures at a research facility in Wuhan. Multiple media outlets have revealed that US scientific diplomats conducted several visits to the Wuhan Institute of Virology (WIV) in 2018 and sent two official warnings back to Washington regarding inadequate safety measures at the facility, which was conducting risky studies on coronaviruses from bats. Officials noted that there was not enough appropriately trained staff to operate such a facility safely. There is little to no evidence that COVID-19 was specifically engineered, with the majority of scientific opinion stating that it originated in wildlife. However, the emergence of diplomatic cable stating the WIV could pose a threat to public health raises the possibility that the COVID-19 pandemic started due to a lab accident at the facility.
